Information about your device, hardware, and software, such as hardware and component configurations, software updates.

Payment Information

All billing and financial information is processed by third-Parties (such as: Apple, Google, etc). Oktagon Games does not store any billing information regarding its customers' purchases

Customer Support Correspondence

When you ask for assistance from our Customer Support team, we will collect and store the contact information you provide (generally your name and e-mail address), information about your game play or activity on the Service, and your user ID number. We will also store the correspondence and any information contained within.

Push Notifications and Local Notifications

With your consent We may send push notifications to your mobile device to provide game updates and other relevant messages. You can manage push notifications from the "options" or "settings" page of the relevant game. You can also manage them on your device's settings page for the relevant game.

We can send local notifications to your mobile device to provide game updates and other relevant information. You can manage local notifications on the "options" or "settings" page of the relevant game.
